### 3.0 14 December 2020 Meeting: Key Decisions and Discussions

### 3.1 Media Activities Update

- 3.1.1 Janet Flaherty gave Governors an update of the media activities in the Trust:
  - A homelessness fair in Hackney received BBC interest but more importantly was a great success with nearly 130 homeless people attending.
  - There was interest by the One Show in interviewing the ELFT black cab driver as this was an innovative move by the Trust.
  - There are plans to add a 'chat bot' to the ELFT website which will enable people to access information without having to call or email services.
  - The Trust has started virtual waiting rooms for Newham Phlebotomy service to stop people having to queue outside for their blood tests due to social distancing; plans were put in place to communicate this more widely
  - There has been media work about our three new Non-Executive Directors.
  - Messaging around Brexit is challenging as there is little clarity about what will happen.
  - There are plans in hand for messaging around Christmas about a variety issues from loneliness to foot health.

#### 3.2 Chair of the Committee

- 3.2.1 The Committee unanimously re-elected Jamu Patel as its Chair.
- 3.2.2 Felicity Stocker will remain Vice-Chair.

## 3.3 NHSE Consultation on Integrated Care

- 3.3.1 The Committee discussed the recent NHSE consultation around integrated care and the planned session on this on 17 December 2021 to be led by Richard Fradgley.
- 3.3.2 The Committee raised the importance of ensuring Governors are kept updated and where appropriate consulted to enable Governors to meet their duties regarding public accountability.

### 3.4 Membership Strategy

- 3.4.1 The Committee has started the process of reviewing the membership strategy. The current strategy dates from 2016 and is a 13-page document. The aim is to present an updated draft in the same format as the Trust Strategy, as a one page driver diagram.
- 3.4.2 The new draft membership strategy will be jointly agreed by the Council of Governors and the Trust Board...
