**Subject:** Governor Engagement Update

## 1.0 Purpose of the Report

1.1 To update the Council on the current state of Governor and membership engagement following the raising of Covid Alert to Level 5.

## 2.0 Background

2.1 The Government ordered a lockdown for London and the South East on 21 December 2020 and the Covid-19 alert level was raised from Level 4 to Level 5 on 4 January 2020.

## 3.0 Impact

- 3.1 Mindful of these changes, and the demand on other staff, the Chair, Corporate Governance Manager and Lead Governor have agreed the following changes in line with precedent from the first lockdown in March 2020 (see Appendix 1); these changes also have the support of the Chairs of the Communications and Engagement and Significant Business Committees:
  - Except for Council of Governor Meetings and those Nominations and Conduct Committee meetings dealing with the recruitment of the Chief Executive, all other formal Council-related meetings have been deferred until at least 31 March 2021
  - As with Board meetings, Council meetings will be reviewed to focus on urgent business and the Governors' strategic priorities.
  - Likewise, all membership engagement events (Stakeholder Lunch Meetings) have been cancelled; future dates will be reviewed following 31 March 2021
  - The planned Trust-wide Annual Plan meeting scheduled for 23 February 2021 has been deferred pending review as NHS England state that "The annual NHS finance and operational planning rounds would be delayed to quarter one of next year, due to "relentless pressure" on trusts, with current rules rolled over into 2021-22.".
- 3.2 Mindful of the need for Governors to remain engaged and informed, the following will continue or will be established:
  - We will continue with the programme of Governors Open Forums, giving Governors the opportunity to have conversations with individual Non-Executive Directors and to meet new NEDs.
  - We have established a series of bi-monthly meetings for all Staff Governors and will be contacting the Appointed Governors to see if there is interest in meetings like these for them as well.

- Governors will continue to receive the regular staff Covid-19 updates, as well as regular updates from the Gold Command Directors, as well as other helpful information.
- We have established a fortnightly Zoom meeting as an offer for Governors to dial into, to check in with each other and raise any issues of concern. Any issues or concerns raised will be taken forward from these meetings and will be raised with the Trust and responses shared with Governors.
- Governors can continue to raise any queries directly with the Governors and Members Office as previously and wherever appropriate, feedback on any queries will be shared with all Governors.
- 3.3 In terms of staffing for the Governors and Members Office, the impact has been as follows
  - Gold Command has increased its the frequency of its meetings to daily meetings; Membership Officer Meena Patel is seconded as Business Manager in support of Gold Command.
  - The team's apprentice, Tajmina Khan, will be working as administrative supportive for the Trust's vaccination hub at Stratford Westfield as of 18 January 2021.
  - Norbert Lieckfeldt is additionally supporting Cathy Lilley and the Board in the process of recruiting a substantive Trust Chief Executive
- 3.4 The Governors and Members Office will communicate these changes to all Trust members by letter or email and will ensure the Website provides accurate updates. In addition, TrustTalk will continue to be published as usual and Governors are invited to provide their own updates as previously.
- 4. The Council of Governors is asked to **RECEIVE** and **NOTE** the report.
