I am writing to request information under the Freedom of Information Act 2000. In order to assist you with this request, I am outlining my query as specifically as possible. I would like to be provided with:

- Question 1. The sex breakdown of all those who failed fit tests for all available masks at your Trust between 1st February 2020 and 30th April 2020.**
- Question 2. The sex breakdown of all those who had to use a powered air purifying respirator at your Trust between 1st February 2020 and 30th April 2020.**
- Question 3. The sex breakdown of all those who failed their fit test for a FFP3 mask at your Trust between 1st February 2020 and 30th April 2020.**
- Question 4. The sex breakdown of all those who failed their fit test for a Disposable Healthcare Respirator, FFP3, Valved, 1873V+ at your Trust between 1st February 2020 and 30th April 2020.**
- Question 5. The sex breakdown of all those who failed their fit test for a Disposable Healthcare Respirator, FFP3, Type IIR, 1863+ at your Trust between 1st February 2020 and 30th April 2020.**

Answer: The Trust does not record the sex of those who failed fit tests for masks or respirators, therefore this information is not held and cannot be provided.

- Question 6. And finally, during the period 1st February 2020 to 30th April 2020, has your Trust been doing fit tests or just fit checks?**

Answer: During the period 1st February 2020 to 30th April 2020, the Trust has been doing FIT Tests.
