Request:

This is a request for information under the Freedom of Information Act 2000. For the period 08 October 2020 – 27 January 2021 I would like to request the following information:

Agency nurses: -

How much has been spent on agency nurses for the above period.

The number of shifts agency nurses have been hired to work and what number of those shifts were to work Covid bays.

The name of each agency and corresponding amount spent on hiring their nurses.

How much was spent on agency nurses between 08 October 2019 – 27 January 2020)?

Permanent Nurses hired and quit:

How many nursing staff have quit in the period and, if recorded, their reason for resignation?

How many nursing staff have been hired in the period outlined?

Nurses at risk due to age or BAME:

Many nurses are not assigned to work Covid bays due to the risks Covid poses to them - what number (and percentage) of your total available nursing staff are currently eligible to work with Covid patients/in Covid bays?

What are the ages – upper and lower limit – considered least at risk when working Covid bays?

Injuries:

How many injuries have been reported by nurses in the process of 'proning' immobile patients – flipping patients from prone to supine and vice versa?

Vaccines:

As of 27 January 2021, how many nursing staff have been vaccinated?

Answer:

The Trust has reviewed your request for information under the Freedom of Information Act (FOI) 2000.

Section 1(1) of the FOI Act states:
