Dear East London NHS Foundation Trust, I would like to request information under the Freedom of Information Act. Please could you provide the following information:

Question 1. What support do you offer for the family members of patients being treated for cancer within your NHS Trust? (Support can include anything that would contribute to the emotional well-being of an individual, such as support groups, counselling or advice).

Answer: In the Trust, staff would liaise with Cancer Nurse specialists to ensure no duplication. A referral would be made to relevant support services.

Question 2. Does your NHS Trust provide any tailored support specifically for young people (under 25s) who have family members being treated for cancer?

Question 3. If so, please could you provide details.

Answer: The Trust has reviewed your request for information under the Freedom of Information Act (FOI) 2000.

Section 1(1) of the FOI Act states:

Any person making a request for information to a public authority is entitled—

(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and (b) if that is the case, to have that information communicated to him.

East London NHS Foundation Trust does not provide tailored support specifically for young people (under 25s) and therefore does not hold the information requested.

Question 4. Are services actively offered to patients' family members, or do they have to approach the Trust themselves to request support?

Answer: If a patient has been referred to the service, the family would be a part

of the initial assessment and any needs identified would be part of a

care plan, along with support from Macmillan.
