I would like to make a request for information under the Freedom of Information Act regarding the following:

Question 1. The spending per financial year on translation services (written) and interpreting services (oral) for your organisation over each of the following 5 financial years:

2015/2016 2016/2017 2017/2018, 2018/2019

2019/2020, as well as the languages involved.

Please do not include data regarding the spending on services for the deaf and blind (such as sign language interpreting or Braille).

Answer: The Trust has reviewed your request for information under the Freedom of Information Act (FOI) 2000.

Question 2. The total budget for your organisation for each of the 5 financial years the information above is provided on, for all expenses not just for translation and interpreting services, i.e. to include all expenses such as salaries, utilities, equipment, consumables etc., with only the total figure given, no breakdown necessary. For example, I assume the total budget would be a few dozen or hundred million pounds per financial year. This is so that I can calculate the translation and interpreting spending as a percentage of the organisation's total budget (which I suspect would be around or under 0.1%).
