I am responding to your request for information received 17 February 2021. I am sorry for the delay in responding to your request. This has been treated as a request under the Freedom of Information Act 2000.

When an organisation receives a request for information under the Freedom of Information Act, it is allowed under the Act to apply a blanket exemption to this where it has concluded that providing a response would take in excess of eighteen hours. When the cost of compliance and extracting information would exceed eighteen hours, a cost limit of £450 can be applied. This is explained in Section 12 of the Freedom of Information Act 2000 and is based on a rate of £25 per hour, regardless of the rate of pay of any individual involved in the retrieval of requested information, and equates to eighteen hours work.

Having reviewed your request, the Trust has noted that it would not be able to all the information requested within the eighteen hours specified in the Freedom of Information Act 2000.

In order to assist you with your request, I have advised below the timing each question would take in order to assist you to refine your request. If you wish to refine your request to comply with the 18 hour time limit, please do get in touch

Request:

- Question 1. The total number of patients admitted to an inpatient mental health unit every month broken down into voluntary/informal and sectioned patients for the following years:
 - a. 01/2018 to 12/2018
 - b. 01/2019 to 12/2019
 - c. 01/2020 to 12/2020

Answer:

The question would take two hours to collate and can therefore be responded to within the 18 hour time limit.

- Question 2. The total number of patients that are inpatient in a mental health unit at the end of the month broken down into voluntary/informal and sectioned patients for the following years:
 - a. 01/2018 to 12/2018
 - b. 01/2019 to 12/2019
 - c. 01/2020 to 12/2020

Answer:

The Trust has reviewed your request for information under the Freedom of Information Act 2000. In order to collate this information, staff would have to retrieve the information for every month. Each moth would take an hour to collate and therefore, 36 months would take 36 hours to collate.

That being the case, the Trust is unable to comply with this particular part of your request as the cost of compliance and extracting your exact requirements would exceed the appropriate cost limit of £450 which is specified in Section 12 of the Freedom of Information Act 2000. This is based on a rate of £25 per hour, regardless of the rate of pay of any individual involved in the retrieval of requested information, and equates to 18 hours work.
