**Dear East London NHS Foundation Trust,** 

Please find below a request made under the FOI Act.

Question 1. How many cyber-attacks (incidents) did your organisation experience in the last 3 years?

Answer: The Trust experienced zero cyber-attacks in the last three years.

- Question 2. If these statistics are available within the cost limit, how many of those incidents involved
  - a) Malware
  - b) Ransomware
  - c) Hacking
  - d) Phishing emails
- Question 3. How many incidents over the last 3 years were reported to the Department of Health and Social Care, whether under the Security of Network and Information Systems Regulations 2018, or otherwise?
- Question 4. How many incidents over the last 3 years resulted in a notification to the Information Commissioner's Office?
- Question 5. How many incidents over the last 3 years were reported to both DHSC and the ICO?

Answer: The Trust has reviewed questions 2-5 of your request for information under the Freedom of Information Act (FOI) 2000.

Section 1(1) of the FOI Act states:

Any person making a request for information to a public authority is entitled—

(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and (b) if that is the case, to have that information communicated to him.

The Trust has not experienced any cyber-attacks in the last three years and therefore does not hold the information requested.
