**Request:**

**I would like to obtain the following information:**

- Question 1.** The **TOTAL NUMBER** of Hospital admissions attributed to heat-stroke **AND/OR** heat exposure **AND/OR** fluid and electrolyte disorders **AND/OR** dehydration **AND/OR** sunstroke for your trust.
- Question 2.** I am not specifying an **AGE CATEGORY** – I just require total no. of admissions.
- Question 3.** **TIMESCALE:** from **JUNE** through to **AUGUST**, for **YEARS 2019 AND/OR 2020 AND/OR 2021**.
- Question 4.** **IF** data is not available as recently as these years (**2019, 2020, 2021**), then previous yearly data would still be desirable.
- Question 5.** I would like to obtain this information preferably in an excel spreadsheet format but would welcome any dataset made available

**Answer:** Section 1(1) of the Freedom of Information Act 2000 states:

*Any person making a request for information to a public authority is entitled—*

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and*  
*(b) if that is the case, to have that information communicated to him.*

East London NHS Foundation Trust is a mental and community health trust and does not manage hospital admissions attributed to heat-stroke, heat exposure, fluid and electrolyte disorders, dehydration or sunstroke. The Trust does not hold the information requested and it is therefore not disclosable.
