## Request

Question 1. The number of Black patients that have been inpatients at East London Community Mental Health Trust - specifically a locked ward - over the last 10 years.

Answer: Section 1(1) of the Freedom of Information Act 2000 states:

Any person making a request for information to a public authority is entitled—

(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and

(b) if that is the case, to have that information communicated to him.

East London NHS Foundation Trust does not have "locked wards". The Trust does not hold the information requested and it is therefore not disclosable.

Question 2. The number of White patients that have been at East London Community Mental Health Trust - specifically a locked ward over the last 10 years.

Question 4. Details of court proceedings over the last 10 years of discrimination within at East London Community Mental Health Trust against Black inpatients
