58% of LGBT employees said yes 53% of non-LGBT employees said yes

65% of LGBT employees agreed 66% of non-LGBT employees agreed

As a result of the training, I understand trans identities...

57% of LGBT employees agreed 57% of non-LGBT employees agreed

75% of LGBT employees said yes 71% of non-LGBT employees said yes

Over the past year I have taken part in LGBT employee network group activities, events, initiatives or seminars...

46% of LGBT employees said yes 29% of non-LGBT employees said yes

I am aware of the activities the LGBT employee network group undertakes...

72% of LGBT employees agreed 68% of non-LGBT employees agreed

I would feel confident approaching my employer's LGBT employee network group for confidential support or advice...

69% of LGBT employees agreed 70% of non-LGBT employees agreed
