Answer: The Trust has reviewed your question above as a request for

information under the Freedom of Information Act 2000 and is applying section 22 of the FOI Act. Section 22 Exemption relates to information intended for future publication. The Trust has applied this exemption because the requested information is due to be published at a later date. We confirm that the information is held and the Trust's Estate plan is yet to be approved before publication. As this is a qualified exemption, the public interest in withholding the information should outweigh the public interest in disclosure. We have considered the balancing of the public interests and confirm that this information cannot be released until its future publication to ensure its accuracy.
