the ECT team in 2018.


Question 5. What proportion of patients were men/women?

Question 6. How old were they?


Answer: Please see diagram below for a breakdown of the age ranges of

Question 21. How does the Trust plan to prevent ECT in the future?

Answer: ELFT provides an ECT service for its patients in line with the **NICE**

Guidance Technology Appraisal No. 59 dated April 2003 updated on May 2010 and NICE Clinical Guidance for Depression (CG 90) dated Oct 2009. ECT is an evidence based intervention recommended by NICE which is made available to patients and will continue to be offered in line with NICE Guidance for as long as required. The service is ECTAS regulated and provided to high standards. There are a number of other interventions such as rTMS and Ketamine infusion

a number of other interventions such as rTMS and Ketamine infusion for depression. The Trust is considering introducing these treatments

in future.
