Question 1. Please can you tell me how many people sectioned under section 2 or 3 of the Mental Health Act with a primary diagnosis of dementia were given section 117 aftercare services over the past 5 years. Please provide a figure for each year.

## Question 2. In each case, please can you state where the aftercare services were provided and how much funding each patient was given to help pay for the aftercare services.
