1.0 Background/Introduction

- 1.1 Under its constitution, the powers of the Trust may be exercised by the Board on behalf of the Trust and any of these powers may be delegated to a committee of Directors (paras 3.2 and 3.3 respectively)
- 1.2 The Board of Directors Standing Orders (SOs) requires the Board to approve the appointments to each of the committees it has formally constituted (SO 5.6)
- 1.3 The Board has previously approved its committee structure to support its corporate governance arrangements and achievement of the Trust's strategic priorities, which comprises:
 - Appointments & Remuneration Committee
 - Audit Committee
 - Finance, Business & Investment Committee
 - Mental Health Act Committee
 - People Participation Committee
 - Quality Assurance Committee.

2.0 Board Committee Membership

- 2.1 Three Non-Executive Directors (NEDs) Millie Banerjee, Paul Hendrick and Kingsley Peter have stood down as Non-Executive Directors of the Trust with effect from 31 October 2018 following completion of their terms of office
- 2.2 As previously reported to the Board, Aamir Ahmad, Anit Chandarana and Eileen Taylor have been appointed as NEDs of ELFT with effect from 1 November 2018 for a three year period
- 2.3 Marie Gabriel, Chair of the Trust, reviewed the resultant vacancies on the committees and taking account of the skills and experience of the new NEDs is recommending their committee membership as follows:
