1. Background/Introduction

1.1. This report updates the Board on the Council of Governors discussions so that these views inform Board decisions. 2. Major Developments

- 2.1. The Trust continues to operate under very tough conditions as it exits the winter period. I should like to commend all colleagues for their professionalism, diligence, and sheer dedication. We should remember a year on after the first national lockdown, the many lives lost and the toll the pandemic has had and continues to have on families and communities.
- 2.2. I am delighted to confirm Paul Calaminus as our next substantive Chief Executive Officer (CEO), after a full appointments process. Paul has impressed when serving as our Deputy CEO and recently as the Interim CEO leading us through the toughest healthcare crisis the country has ever faced. I have no doubt he will continue to impress as he leads the organization in refreshing its strategy to deliver integrated community care and to be an impactful regional system partner.
- 2.3. I am pleased that the Trust has been recognized for its work on diversity and inclusion through winning the coveted HSJ NHS Workplace Race Equality annual award. We continue to listen through the Race and Privilege initiative and to create amnesty, equal and just environment for all.

3. Council of Governors

3.1. Since the last Board, the Council of Governors met twice, on 21 January 2021 and 11 March 2021. At both Councils, we reviewed the situation of winter pressures and the second wave of the pandemic.
