- Request: I am writing to make a request for all the information to which I am entitled under The Freedom of Information Act 2002. Please may you provide me with the following:
- Question 1: Does the trust use dogs for any therapeutic or medicinal purposes (eg. PAT / autism/epilepsy/ diabetes assistance) within your hospitals or for patients at home?
- Answer: Yes.
- Question 2: If so, are these dogs engaged as part of the NHS or through an external organisation (such as Support Dogs charity)
- Answer: One dog is PAT registered with the charity. One is engaged as part of the NHS. Other dogs are provided by an external organisation.
- Question 3: Please could you specify how many dogs have been engaged for each of the last ten calendar years (2012-2022), broken down by purpose. (eg. PAT / autism/epilepsy/ diabetes assistance)
- Answer: One dog for therapeutic engagement.

Two dogs for mental health support.

For one service, the number of dogs varies between two and eight as they visit the unit twice a month.

- Question 4: Please list the main breeds used with the most commonly used breeds first.
- Answer: The breeds of dog are Greyhound, Cocker Spaniel and mixed breeds.
- Question 5: How many full time members of staff (trainers, handlers, officers etc) worked with these dogs for each of the years in the same period?
- Answer: One member of staff supports pet therapy along with their substantive role.

Other dogs come with two staff members, externally sourced.

- Question 6: What was the trust's total budget for each of these years and how much was allocated to the dog unit?
- Answer: No budget was allocated to this provision.
