Answer: The Trust has reviewed question 4 of your request for information under the Freedom of Information Act (FOI) 2000.

Section 1(1) of the Freedom of Information Act 2000 states:

East London NHS Foundation Trust does not record the information requested as all printing including consumables is included in an all-in-one package price outsourced to supplier. It is not possible to extract the element that relates purely to consumables. The trust is therefore unable to provide a response.

Question 5: What is the total mono print volume per annum?

Answer: 13,000,000.

Question 6: What is the total colour print volume per annum?

Answer: 800,000.
