Question 1: The number of referrals in to your neurodevelopmental services for young people for 2017, 2021 and 2022.

Question 2: The average wait in weeks for a first assessment/appointment within your neurodevelopmental services for young people for 2017, 2021 and 2022.

Answer: Section 1(1) of the Freedom of Information Act 2000 states:

Any person making a request for information to a public authority is entitled—
(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and

(b) if that is the case, to have that information communicated to them.

East London NHS Foundation Trust does not have the ability to establish the average wait in weeks for neurodevelopmental assessments. In order for the Trust to provide this information it would have to conduct a manual search through patient records. We do not have a legal basis to access patient records in order to respond to a Freedom of Information Request. Therefore, we are unable to provide a response.

Question 3: The number of young people waiting for a neurodevelopmental assessment as of the date of this request or the nearest available date please.

Answer: Section 1(1) of the Freedom of Information Act 2000 states:

Any person making a request for information to a public authority is entitled—
(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and

(b) if that is the case, to have that information communicated to them.

East London NHS Foundation Trust does not hold neurodevelopmental assessment waiting lists on the clinical system. In order for the Trust to provide this information it would have to conduct a manual search through patient records. We do not have a legal basis to access patient records in order to respond to a Freedom of Information Request. Therefore, we are unable to provide a response.

Question 4: The number of young people referred to your neurodevelopmental services who were discharged without an assessment or treatment for 2017, 2021 and 2022 please.

(b) if that is the case, to have that information communicated to them.

East London NHS Foundation Trust does not have the ability to establish how many people were referred and discharged without an neurodevelopmental assessment on the clinical system. In order for the Trust to provide this information it would have to conduct a manual search to through patient records. We do not have a legal basis to access patient records in order to respond to a Freedom of Information Request. Therefore, we are unable to provide a response.

Question 5: The longest wait in weeks of any young person awaiting a first appointment with your neurodevelopmental services as of the date of this request or nearest available date.

Answer: Section 1(1) of the Freedom of Information Act 2000 states:

Any person making a request for information to a public authority is entitled—
(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and

(b) if that is the case, to have that information communicated to them.
