Answer: The Trust has reviewed question 1 of your request for information under the

Freedom of Information Act (FOI) 2000.

East London NHS Foundation Trust does not record nursing vacancies by speciality as requested and is therefore unable to provide a response.

However, the Trust can report the total number of nursing vacancies currently within the Trust: 438.69

Question 4: What was the international nurse recruitment spend by the trust for the


financial year 22/23?
