I am responding to your request for information received 15 August 2023 and clarified on 23 August 2023. I am sorry for the delay in responding to your request. This has been treated as a request under the Freedom of Information Act 2000.

When an organisation receives a request for information under the Freedom of Information Act, it is allowed under the Act to apply a blanket exemption to this where it has concluded that providing a response would take in excess of eighteen hours. When the cost of compliance and extracting information would exceed eighteen hours, a cost limit of £450 can be applied. This is explained in Section 12 of the Freedom of Information Act 2000 and is based on a rate of £25 per hour, regardless of the rate of pay of any individual involved in the retrieval of requested information, and equates to eighteen hours work.


Having reviewed your request, the Trust has noted that it would not be able to provide all the information requested within the eighteen hours specified in the Freedom of Information Act 2000. However, in this instance and in order to assist you, we have provided a partial response to your request as per below.

Request: Please could you provide me with the following data:

Question 1: How many patients have developed a new pressure ulcer each month

(please specify staging of pressure ulcers) for the last 12 months within your

Trust?

Answer: The Trust estimates it would take one hour to collate this information.

Question 2: How many patients have developed hospital acquired pressure ulcers each

month (please specify staging of pressure ulcers) for the last 12 months

within your Trust?

Answer: The Trust estimates it would take one hour to collate this information.

Question 3: The number of pressure ulcers declared as a serious incident each month

for the last 12 months within your Trust?

Answer: There were no serious incidents raised within the Trust in the past twelve months.

Question 4: What percentage of patients had a pressure ulcer risk assessment

completed upon admission to your caseload over the last 12 months?

Answer: The Trust estimates it would take one hour to collate this information.

Question 5: What are your targets regarding pressure ulcer incidence reduction as a

Trust?

Answer: The Trust has no set targets however as part of a QI project we were able to

demonstrate that we made a 31% reduction in pressure ulcers of all categories

and a 50% reduction in Moderate Harm Pressure ulcers (Cat 3,4 and

Unstageable) Trust wide.

Question 6: What is your overall pressure ulcer prevalence each year for the last 5

years?

Clarification: By prevalence, I am referring to the amount of pressure ulcers seen within

the Trust each year for the last 5 years.

Answer: The Trust has reviewed question 6 of your request for information under the

Freedom of Information Act (FOI) 2000.

Section 12(1) of the Freedom of Information Act 2000 states:


Section 12(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request

would exceed the appropriate limit.

When the Trust identifies that the request is likely to take over 18 hours, we are not obliged to provide information for any part of the request. We are required to provide advice on how you may refine your request to information that can be collated within the 18 hour timeframe. You may then choose what information you would like to receive and confirm the same to us, upon which we will process your

request.

The Trust has reviewed your request for information and in order to collate this information, staff would have to check each incident reported over the last five years to establish how many pressure ulcers each incident related to. It is estimated it would take approximately 390 hours to complete this.

Therefore, the Trust is unable to comply with this particular part of your request as the cost of compliance and extracting your exact requirements would exceed the appropriate cost limit of £450 which is specified in Section 12 of the Freedom of Information Act 2000. This is based on a rate of £25 per hour, regardless of the rate of pay of any individual involved in the retrieval of requested information, and equates to 18 hours work.

The Trust's process for reviewing pressure ulcer incidents was revised in April 2022 and accurate information can be provided regarding pressure ulcers from April 2022 to date. This can be provided within two hours.
