Answer: The wholly owned subsidiary is Compass Wellbeing CIC and the PFI is provided by GH Newham Limited. Please note, the Trust does not own the PFI.

Answer: There is no end date for the wholly owned subsidiary and the PFI end date is 2032.

Answer: There is a website for the wholly owned subsidiary but not for the PFI.

Answer: There is no renewable arrangement for either the wholly owned subsidiary or the PFI.
