Question 1: Does East London NHS Foundation trust have specialist midwives dedicated to supporting women who use substances during the perinatal period?

Answer:

The Trust has reviewed question 1 of your request for information under the Freedom of Information Act (FOI) 2000.

Section 1(1) of the Freedom of Information Act 2000 states:

East London NHS Foundation Trust does not employ midwives and is therefore unable to provide a response.
