Answer: The Trust does not have an Electronic Document Management (EDM)

system. Our primary clinical records system is electronic and any attachments

are scanned on to the clinical system.

The Trust uses the following clinical systems for digitised patient records:

EMIS / RIO / Carepath / SystmOne.

Question 2: The current total amount of data stored in the system. Please provide this in terabytes (TB).


