Section 40 for the FOI Act states:


(2) This exemption covers the personal data of third parties (anyone other than the requester) where complying with the request would breach any of the principles in the UK GDPR.

There is no legal basis to access patient records for the purposes of responding to a Freedom of Information request. The Trust is therefore unable to provide a response.



Planned Capital Development Works (Forensics): Answer:

> Our provider collaborative has proposed a transformation of inpatient women's services. If this is formally ratified, Bow Ward (women's Medium Secure ward) would reduce from 15 inpatient beds to 12 beds this financial year, with the remaining beds being transferred to a different provider within the Collaborative.

- There is currently an empty ward which was previously Ludgate Ward men's Medium Secure ward) and the service is currently looking at options in terms of how this space could be repurposed. It may be that a ward or a number of wards temporarily relocates to Ludgate Ward to decant whilst their wards are refurbished.
- There are no current plans to move wards temporarily for the purpose of decant for redecoration after Morrison Ward, which is currently decanted to Ludgate Ward. Please note that no bed capacity is lost in instances where decant takes place.
