Answer: Currently, there are 11,670 patients open to the Trust's ADHD services.

Question 2: What percentage of ADHD patients are prescribed stimulant medication?

Clarification: What percentage of ADHD patients are prescribed stimulant medication right now as you respond to this request?

Answer: The Trust has reviewed question 2 of your request for information under the

Freedom of Information Act (FOI) 2000.

Section 1(1) of the Freedom of Information Act 2000 states:

(b) if that is the case, to have that information communicated to them.

East London NHS Foundation Trust does not record the percentage of patients that are currently prescribed stimulant medication as requested and is therefore unable to provide a response.
