Question 1a: In October 2024, the Trust stated that it does not have fixed capacity for remote patient monitoring enabled virtual ward beds and is scoping how capacity can be captured in the future. Did the remote patient monitoring enabled virtual wards capacity now can be captured, and if so What is the current capacity?

Answer: Whilst we have access to remote monitor this only became live in January

2025. Our capacity for Frailty Virtual Ward (consultant led) is currently 15, but to date we have not had any patients where remoting monitoring has been

utilised.

Question 1b: What is the current utilisation percentage of remote patient monitoring enabled beds?




