**Answer:** The Trust has reviewed question 1 of your request for information under the Freedom of Information Act (FOI) 2000.

**Question 3: Details of any serious incidents or patient safety incidents where Right Care, Right Person was a factor**

**I believe the Metropolitan Police implemented Right Care, Right Person at the start of November 2023, so the timeframe is likely to start then and run to the present day.**

**Answer:** Nil incidents identified where Right Care, Right Person was a factor.
