East London NHS Foundation Trust does not routinely record instances where a patient does not have a diagnosis of cancer in relation to other conditions such as Oedema/Lymphedema. As such, we are unable to provide the data you have requested, as it is not held in a recorded format.

- No policy for foot ulcers in people with diabetes but as part of our service spec, patients are seen within the FH service in CHS London.
 We see non-diabetic foot ulcers as part of our service criteria. However we have a policy for escalation when a patient presents with a deteriorating non-diabetic foot ulcer.
- No policy for lower limb oedema/Lymphoedema as this is managed by Acceleratecic.

Mobile patients managed externally by Acceleratecic


