Request: I am writing under the Freedom of Information Act to request information

regarding the use of simulation-based training within your Trust. Specifically, I would be grateful if you could provide the following

details:

Question 1: Does the Trust currently use simulation to train any staff groups (e.g.,

consultants, resident doctors, nurses, allied health professionals, etc.)?

Answer: Yes.

Question 2: If yes, what simulation methodologies are employed (e.g., role-play with

actors, digital avatars, augmented reality, virtual reality, or other

approaches)?

Answer: Role play with actors and use of cameras to run group debrief sessions post

scenario.

Question 3: What were the initial setup costs for implementing simulation training?

Answer: Cost of Single Sequence-Multi Objects Training (SMOTs) simulation

equipment £16,819.20.

Question 4: What are the ongoing annual costs, if any, associated with maintaining

and delivering simulation training?

Answer: Actor costs £125 per day per actor (two per session – Annual cost

approximately £6500.

Approximately £50 per year - we currently only provide tea and coffee.

Number of sessions and actors vary every year depending on the number of

simulation sessions run.

Question 5: How many trainees did the Trust host in the last financial year

(2024/2025) who were enrolled in training for a mental health-related

profession?

Answer: Over 160 - numbers vary by cohorts/depending on how many trainees we

have.
