I am responding to your request for information received 15 October 2025. This has been treated as a request under the Freedom of Information Act 2000.

When an organisation receives a request for information under the Freedom of Information Act, it is allowed under the Act to apply a blanket exemption to this where it has concluded that providing a response would take in excess of eighteen hours.

When the cost of compliance and extracting information would exceed eighteen hours, a cost limit of £450 can be applied. This is explained in Section 12 of the Freedom of Information Act 2000 and is based on a rate of £25 per hour, regardless of the rate of pay of any individual involved in the retrieval of requested information, and equates to eighteen hours work.


Having reviewed your request, the Trust has noted that it would not be able to provide the information requested within the eighteen hours specified in the Freedom of Information Act 2000.

Request:

We act on behalf of a client who believes he may have been exposed to asbestos dust whilst working as a nurse at the following location: Hackney Hospital, Homerton High Street (since demolished)

We make a request under the terms of the Freedom of Information Act 2000 and should be grateful if you could provide us with copies of the following documents, relating to the hospital and associated premises, from any stage between 1960 and 1970:

Question 1:

Copies of any asbestos surveys identifying or detailing asbestos use within the hospital, including details of any asbestos surveys carried out in respect of the hospital
