I am responding to your request for information received 29 August 2025 and clarified on 1 September. I am sorry for the delay in responding to your request. This has been treated as a request under the Freedom of Information Act 2000.

When an organisation receives a request for information under the Freedom of Information Act, it is allowed under the Act to apply a blanket exemption to this where it has concluded that providing a response would take in excess of eighteen hours.


When the cost of compliance and extracting information would exceed eighteen hours, a cost limit of £450 can be applied. This is explained in Section 12 of the Freedom of Information Act 2000 and is based on a rate of £25 per hour, regardless of the rate of pay of any individual involved in the retrieval of requested information, and equates to eighteen hours work.

Having reviewed your request, the Trust has noted that it would not be able to provide all the information requested within the eighteen hours specified in the Freedom of Information Act 2000. However, in this instance and to assist you, we have provided a partial response to your request as per below.

Request:

Question 1: How many active Employment Tribunal claims are currently ongoing

against your Trust and what are the projected legal costs of these

cases?

Answer: Currently the Trust has 29 active Employment Tribunal cases.

The Trust has reviewed your request for information under the Freedom of Information Act (FOI) 2000.

Section 1(1) of the Freedom of Information Act 2000 states:

Any person making a request for information to a public authority is entitled—
(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and

(b) if that is the case, to have that information communicated to them.

East London NHS Foundation Trust does not record projected legal costs of these cases and is therefore unable to provide a response.

Question 2: How many Employment Tribunal claims has your Trust had in the last five years and what was the total cost of these cases.

Clarification: I would be interested in receiving the figures for the total of defense costs plus any settlement costs.

Answer: The Trust has reviewed question 2 of your request for information under the Freedom of Information Act (FOI) 2000.

Section 12(1) of the Freedom of Information Act 2000 states: Section 12(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit

The Trust has reviewed your request for information and in order to collate this information, it would be necessary to review thousands of invoices over a five year period to enable us to identify relevant invoices as to whether they relate to employment tribunals and defence costs including legal fees, and then calculate the totals. This is estimated to take over 18 hours to collate.

Section 16(1) of the Freedom of Information Act 2000 states: Section 16 (1) It shall be the duty of a public authority to provide advice and assistance, so far as it would be reasonable to expect the authority to do so, to persons who propose to make, or have made, requests for information to it.

Under Section 16 of the Freedom of Information Act, the Trust has a duty to provide a reasonable level of advice and assistance. As such, the Trust can disclose the following information to assist you with your request.

In the last five years since 2019 the Trust has had a total of 46 tribunal cases which had claims. The total cost of defending these cases including settlement costs was £388,365.60 excluding legal fees.
