Question 1: Confirmation of whether these services have had any training relating to

Premenstrual Dysphoric Disorder (PMDD) in the past 2 years.

Answer: PMDD-specific training is not a mandatory requirement within the service.

However, the Trust's Academic Afternoon teaching programme for doctors has included a session covering PMDD within the past two years. Resident

doctors would have attended this session.

Question 2: If so, copies of training documents, workshops or e-learning modules

and any strategies in place relating to it in the past 2 years (as well as

titles, dates, providers of such training, and target staff groups).

Answer: The available training materials relating to PMDD are included in the attached

documents. These consist of the slide deck and accompanying resources from the Trust-wide Academic Afternoon teaching session referenced above. These materials contain the educational content delivered to medical staff. No

additional PMDD-specific workshops or e-learning modules have been

identified.

Question 3: Any clinical guidelines, protocols, or care pathways used by the service

that reference PMDD.

Answer: The service does not hold separate internal guidelines, protocols, or care

pathways specifically relating to PMDD. The management section contained

within Appendix 1 of the PMDD presentations reflects the standard

management recommendations used in clinical practice and represents the

guidance followed within the service.

Question 4: Whether any audit or evaluation has been done to measure how often

PMDD is identified or diagnosed.

Answer: No audits or evaluations have been undertaken within the given services to

measure the frequency of PMDD identification or diagnosis.

Question 5: Whether the services refers to or works with any specialist PMDD or

women's health teams.

Answer: There is currently no formal referral pathway or specific service provision for

PMDD within the teams. Where clinically indicated, cases can be discussed through existing internal processes, including multidisciplinary complex case

discussions and consultant-led complex case reviews.
