**Request:** Identifying which children, within the past year, have been admitted and placed under Section 3, as well as those detained under forensic sections 37, 45A, 47, and 48, who would therefore have been eligible for the S117 offer.

There has been ongoing work regarding S117, particularly given the lack of an agreed pathway in Tower Hamlets and beyond. This is now being addressed through new NEL-level improvement work. To support this, we need to understand the local S117 cohort both LDA and non-LDA in order to identify who is eligible, who is receiving the offer, and who may not be.

**Answer:** The Trust has reviewed question 1 of your request for information under the Freedom of Information Act (FOI) 2000.

Section 21(1) of the FOI Act states:
