Request:

The following questions relate to offices of the Trust's estate, at 22 Commercial Street, London, E1 6LP. The relevant period of interest is 2005 to the present day.

Question 1: In relation to 22 Commercial Street, London, E1 6LP, please confirm:

- a) the locations within the building which were known to contain asbestos
- b) The materials containing asbestos (i.e. ceiling tiles, floor tiles etc)
- c) The type of asbestos used in those materials
- d) Any works undertaken to remove asbestos containing materials from 2005 to the present date, and when this work was undertaken.

Answer: The Trust has reviewed question 1 of your request for information under the Freedom of Information Act (FOI) 2000.

Section 1(1) of the Freedom of Information Act 2000 states:

*Any person making a request for information to a public authority is entitled—
(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
(b) if that is the case, to have that information communicated to them.*

East London NHS Foundation Trust does not record the information requested. The Trust only occupied the building as a tenant until 2014 when the Trust left the premises and prior to that all relevant records would have been held by or provided to the landlord of the property. The Trust is therefore unable to provide a response.

Question 2: Details of any reported incidents involving asbestos at 22 Commercial Street, London, E1 6LP from 2005 to the present day;

- d) any other surveys that have considered the locations or existence of asbestos within 22 Commercial Street, London, E1 6LP.
