I am responding to your request for information received 15 October 2025. I am sorry for the delay in responding to your request. This has been treated as a request under the Freedom of Information Act 2000.

When an organisation receives a request for information under the Freedom of Information Act, it is allowed under the Act to apply a blanket exemption to this where it has concluded that providing a response would take in excess of eighteen hours.

When the cost of compliance and extracting information would exceed eighteen hours, a cost limit of £450 can be applied. This is explained in Section 12 of the Freedom of Information Act 2000 and is based on a rate of £25 per hour, regardless of the rate of pay of any individual involved in the retrieval of requested information, and equates to eighteen hours work.

Having reviewed your request, the Trust has noted that it would not be able to provide all the information requested within the eighteen hours specified in the Freedom of Information Act 2000. However, in this instance and to assist you, we have provided a partial response to your request as per below.

Request:

Question 1: How many active commercial technology contracts does your Trust currently hold?

For each contract, please provide:

- a) **The contract title or name.**
- b) **The supplier/vendor name.**
- c) **How long each of the contracts are currently held for.**
- d) **The start date and current end/expiry date.**
- e) **The annual value or average yearly spend under each active commercial technology contract.**
- f) **If the contract includes any extension or renewal options? If yes, please state the length and terms of these extensions.**
- g) **Specify if any of these contracts relate specifically to cloud hosting or data center services.**

Answer: The Trust has reviewed question 1 of your request for information under the Freedom of Information Act (FOI) 2000.

Section 12(1) of the Freedom of Information Act 2000 states:

Section 12(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.

The Trust has reviewed your request for information and in order to collate this information, it would be necessary to review and collate all relevant contractual information as requested. The Trust estimates that it would take over 18 hours to collate this information.

Section 16(1) of the Freedom of Information Act 2000 states:

Section 16 (1) It shall be the duty of a public authority to provide advice and assistance, so far as it would be reasonable to expect the authority to do so, to persons who propose to make, or have made, requests for information to it.

Under Section 16 of the Freedom of Information Act, the Trust has a duty to provide a reasonable level of advice and assistance. As such, the Trust is disclosing the latest register with relevant contracts that is currently available to assist you with your request. Please see attached Appendix 1 for list of current ELFT active commercial technology contracts, along with available information.

- h) **A brief description of the product or service covered by the contract, for instance type of technology or digital service covered (e.g. Electronic Patient Records, Cybersecurity, AI tools, Telephony).**

Answer: The Trust has reviewed your request for information under the Freedom of Information Act (FOI) 2000.

Section 1(1) of the Freedom of Information Act 2000 states:

*Any person making a request for information to a public authority is entitled—
(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
(b) if that is the case, to have that information communicated to them.*
