Answer: £673,006.74 total Trust spend in this period on locum AHP/HSS staffing.

The Trust has reviewed question 3 of your request for information under the Freedom of Information Act (FOI) 2000.

Section 1(1) of the Freedom of Information Act 2000 states:
*Any person making a request for information to a public authority is entitled—
(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
(b) if that is the case, to have that information communicated to them.*

East London NHS Foundation Trust does not record the information requested. The Trust does not use an internal or associated external provider for any locum AHP/HSS staff provided by the Trust bank and cannot split spend by specialty or agency name. The Trust is therefore unable to provide a response.

Section 40 for the FOI Act states:

The banding information you have requested has the potential for individuals to be identified. The Trust is therefore unable to provide such information.

East London NHS Foundation Trust does not set budgets for agency staffing. Where a vacancy arises that cannot be filled through internal bank staff, agency staff may be allocated to the post as required. As such, the Trust does not hold the requested information in the format specified and is therefore unable to provide a response.
