## **Introduction & Summary**

This job description is for a core training post in a Personality Disorder Service, working at Mile End Hospital in Tower Hamlets.

The post holder will spend six months in this post, under the Clinical Supervision of Dr Lee.

The post-holder will gain experience in achieving the following aims and objectives:

#### Aims

1. Development of skills in thinking as a psychodynamic psychiatrist, for example what are the transferential issues which may exist in drug prescribing to a particular patient

### Objectives: development of

- 1. Skills in taking a detailed psychiatric history in patients with complex histories
- Skills in assessment and management of comorbid psychiatric problems
   Skills in development of psychodynamic formulations
- 4. Skills in assessment and classification of patients with personality disorder
- 5. Skills in psychotherapy treatment of patients with personality disorder
- 6. Skills in pharmacological treatment of patients with personality disorder
- 7. Skills in the dynamic management of workload with challenging group of patients with complex needs

#### Post specific:

- 1. Development of psychodynamic group therapy skills (cofacilitated by an accredited group psychotherapist)
- 2. Development of skills in an evidence based treatment for PD eg Mentalization-Based Treatment and/or Transference-Focused Psychotherapy
- 3. Development of skills in working in a Personality Service Day Hospital

Other opportunities are for research as DeanCross is also a PD research centre. Output of research with trainees to date includes 5 posters to RCPsych (2015-17), 3 peer reviewed publications and 5 papers in preparation.

## **Brief description / profile of Clinical Supervisor**

Dr Lee is a Consultant in General Adult Psychiatry and Medical Psychotherapy and was previously a senior lecturer in Public Health. Dr Lee has additional trainings in evidence based treatments for Personality Disorder (PD), including Mentalization-Based Treatment and Transference-Focused Psychotherapy, in which he is accredited by the International Society of Transference-Focused Psychotherapy.

Dr Lee has over 25 peer reviewed papers, has recently published a book on Personality Disorder and has established DeanCross as a research centre on PD. He has taught on PD internationally most recently on an online course to China.

## The team (including staffing) / service description

The team members come from multiple disciplines with individual expertise. The team consists of the following disciplines: psychiatry, clinical psychology, psychotherapy (individual and group).

## Role of the Core Trainee (1-3) / Main Duties and Responsibilities

The post-holder will provide a clinical psychiatric service, including

#### Medical

- 1. Clear understanding of medical diagnoses and liaison with relevant treating services
- 2. Assessment and management of psychiatric implications of medical diagnosis and its treatment

#### **Psychiatric**

- 1. Detailed psychiatric assessment of patients with complex histories to allow accurate diagnoses,
- 2. Management of psychiatric diagnoses (including pharmacological management of psychotropic medication)
- 3. Provision of psychiatric care to patients who are in treatment with DeanCross.
- 4. Urgent psychiatric review of patients in programme when indicated.

## **Psychodynamic**

- 1. Participation as a cotherapist in the psychoanalytic groups
- 2. Developing psychodynamic formulations,.

#### Audit and evaluation

1. Assistance with audit and research within the unit

## Any other specific characteristics of this job

- 1. The postholder will be expected to be able to dynamically manage his/her workload with a challenging group of patients with complex needs and to coordinate management of these patients with other members of the team.
- 2. As this is a unit run along psychodynamic lines, scrupulous attention needs to be paid to dynamic administration eg timekeeping for meetings, tone and wording of reports.
