#### **Introduction & Summary**

This job description is for a core training post in MHCOP, working 10 sessions at/in the older adult's inpatient ward, Leadenhall ward at Mile End hospital, and at the MHCOP CMHT at Felstead street.

The post holder will spend one year in this post, under the Clinical Supervision of Dr Pritchard (CMHT) and also providing clinical support to Dr Fawzi (Leadenhall ward)

The post-holder will gain experience in old age inpatient ward management and community psychiatry

Other opportunities are for teaching and training, research and psychotherapy cases

#### **Brief description / profile of Clinical Supervisor**

Dr Pritchard is a consultant psychiatrist in old age psychiatry and college tutor

### The team (including staffing) / service description

The team members come from multiple disciplines with individual expertise. The inpatient ward has a multidisciplinary team with Dr Waleed Fawzi as consultant psychiatrist. The community team consists of community psychiatric nurses, social workers, occupational therapists, psychologists and admin staff as well as nurse and social worker senior practitioners and operational leads for health and for social care.

#### Role of the Core Trainee (1-3) / Main Duties and Responsibilities

The post-holder will provide a clinical psychiatric service, including reviews and management rounds for inpatients under the team's care. The post-holder will carry out assessments of new patients in outpatient and community settings, as well as assessments and reviews for inpatients. The post holder will maintain accurate, legible, contemporaneous and useful clinical records for all patients in whose care they are involved, making appropriate entries on the RIO electronic patient record and completing HONOS scores and care cluster allocation on the electronic system. Under the supervision of the Clinical Supervisors, the post-holder will prescribe pharmacological and psychosocial treatments for the patients and will refer them promptly to other professionals as directed by your Clinical Supervisors. The post-holder may also see patients referred urgently to the CMHT. Most community assessments are performed jointly with members of the team.

The Core Trainee will provide medical care to inpatients admitted to Leadenhall ward.

#### Any other specific characteristics of this job

Teaching opportunities are plentiful. In addition to 2nd and 4th year Medical Students, the department frequently takes clinical attachment doctors from abroad. Trainees are encouraged to be involved with teaching of students and staff.
